Introduction

- [1] The applicant is an incorporated society representing the interests of the commercial kōura/rock lobster fishing industry in the CRA7 (Otago) quota management area.¹
- [2] The applicant has applied for judicial review and/or declaratory judgments regarding decisions by the Minister of Conservation under the Marine Reserves Act 1971 preceding the intended establishment of six marine reserves off the southeast coast of the South Island, together with the concurrence decisions of the Ministers of Transport and (Oceans and) Fisheries (the second and third respondents, respectively).
- [3] The parties have filed a joint memorandum dated 22 July 2024, seeking directions by consent.

- [4] Having considered counsel's memorandum, I make the following orders:
 - (a) the third respondent is to be renamed as the Minister for Oceans and Fisheries;

- (d) the proceeding is categorised as a Category 2 proceeding;
- (e) the parties are excused from attending the Judge's Chambers List on 29 July 2024; and
- (f) the matter will be set down for a case management conference after 6 September 2024.
