My reasons for my objection or submission are:

The Mercury Bay Boating Club is of historical importance to New Zealanders and Whitianga with its close association with the Americas Cup. It holds a significant number of national and regional centreboard and keelboat regattas bring sailors from all around NZ. This supports the local hospitality and business community.

The club has close association with the Mercury Bay Area School and Sea Scouts teaching hundreds of our children how to sail as well as water safety, and awareness.

My reason for my submission in support of this application is that the existing site where the club was located is no longer viable and the clubhouse must be relocated to a suitable location.

The new proposed site:

- 1 Is a good use of under-utilised land.
- 2 Brings the marine community together into one hub, with the yacht club, and the marina and facilities in one area.
- 3 Has an existing carparking area.
- 4 Enables the transportation of the existing clubhouse a viable option. le no powerlines, or obstructions which would prevent transportation.
- 5 Is further away from residential houses than the existing site social/club events will have less impact(eg noise) on residents.

It is also significant and fortunate that this land was previously set aside for the club and marine activities. The site is available fit for purpose and the logical site for the Clubhouse to be sited.

It is essential that the club is given approval to relocate to the Local Purpose Reserve. The Club is not in a financial position to purchase suitable land in Whitianga, and if the application is declined, the Club will cease to exist.
