This is a brilliant Sailing Club and as someone who has sailed a lot over the years and supported this club with family membership in the past, I believe it is absolutely right and proper for yachts and the yachting community to have a home alongside the power boats that are in Whitianga. I was living here when the marina was granted the right to privatise the harbour and it always grated with me. However, what is done is done. This is an opportunity to balance some of the imbalance of marine facilities in Mercury Bay. Millions of dollars of ratepayer's moneys have been spent on launching ramps and parking on shorelines in our District for one sector of boats i.e. power boats. Permitting this lease would allow environmentally low-impact activities and also enable the continuance of teaching valuable sailing skills to young and old.

The proposed small boat launching ramp could in no way have a detrimental impact of the surrounds or the integrity of the rock wall but would be very helpful to young small boat sailors and would be a safer option than sharing the other boat ramp which is used by vehicles launching and retrieving.

The site in question is currently barren and used primarily for parking, often for people who launch their dinghies to go out to their boats on moorings, overflow trailer parking from boats launched at the marina, or daytrippers.. - The proposed relocation away from the Buffalo Beach foreshore to a more robust location sets the right precedent for how community and government should work together to adapt and respond to climate change and other natural processes.
- By making the land at Dundas Street available, DoC will help facilitate the relocation of the clubhouse off an important wāhi tapu site to a more appropriate location a move which acknowledges both the cultural significance of Taputapuatea and the ecological qualities of the surrounding foreshore area.
- The location of the boating club at Dundas Street will complement the adjacent marina activities and will help consolidate public amenities in the central township area.
- The area is zoned for exactly these sorts of activities ("...yacht club, sailing school, coastguard etc.") under the Thames Coromandel District Plan.
- There are no alternative locations with the direct access to the sea or harbour.
- The boat club building together with dinghy ramp in the proposed location will support a wide range of water-based sports and recreational activities (e.g. rowing, kayaking, multi-sport etc.) not currently provided for in the township.
- The clubhouse building will provide options for use by other community groups, including Waka Ama and Scouts/Sea Scouts, both currently without facilities.

I can personally vouch for the site as being safe and entirely suitable for dinghy sailing and a wide range of other water sports. The proposed dinghy ramp will be an added bonus.

The proposal is an excellent turnaround from what looked to be a disaster last year with the near loss of the clubhouse building in the January storms. The remarkable response by the community to save the building is a testament to asset that it is.

This as an excellent solution to the complex issues for all stakeholders at the current site. I urge DoC to recognise this and play their role to help facilitate what will be a win-win for the Mercury Bay Community.

We strongly oppose the use of the reclaimed land on Dundas Street for the purpose of relocating the mercury bay boating club. This site is already substantially over subscribed for parking in traffic over the peak periods and normal weekends. Already boat trailers are required to park kerbside along both sides of Dundas street in peak periods. If this proposal proceeds in my view it will create a substantial health and safety risk as you mix significant volumes of traffic, heavy traffic (trucks and boat trailers) and young children and pedestrians.
